Adobe ETLA Agreement 2016-2019

The new MEEC/ADOBE ETLA Agreement is in place for purchase of Adobe Creative Cloud. Adobe Enterprise Term License Agreements (ETLA) allow organizations to deploy Adobe software in an efficient, cost effective and targeted manner over the three year term of the agreement. Product and pricing information is available from Computer Intelligence Association (CIA), the reseller for Adobe products under the MEEC/Adobe Agreement. Like other MEEC Agreements, the ETLA contains several "Options" depending on the needs of your institution. MEEC Members that choose to participate in the ETLA may also choose to include add-on products such as Premiere Elements, Photoshop Elements, Captivate and Presenter.

IT Professional Consulting Services

MEEC is pleased to announce the establishment of a new agreement, IT Professional Consulting Services. The Agreement provides a wide range of services. The purpose was to create multiple, task-order based Master Contracts to provide information technology professional consulting services on an as needed basis. These contracts commenced on July 1, 2016 and expire June 30, 2025. In Year 3 (2019) and Year 6 (2022), there is an "Expansion Window" whereby the USM/MEEC can solicit to other IT contractors to add them to the list of Master Contractors and the current Master Contractors can propose to expand their services. Contracts were awarded through a competitive proposal process, following the USM procurement policies and procedures. Twenty vendors were awarded

contracts in six categories: ERP Implementation, Upgrade and Integration; Change Management/Strategic Planning; Technology Management; Transition to Cloud Applications, Shared Services and Managed Services; Analytics; and Training.

Intel Security/McAfee- Symantec Awards

The University of Maryland, Baltimore, on behalf of MEEC has issued two RFPs to contract with Intel Security formerly McAfee and Symantec anti-virus reseller to procure, support and distribute endpoint protection and other security products for academic licensing and services to MEEC members. MEEC will announce the awards in early October.

MEEC Hardware RFP

The MEEC Hardware Agreement will expire in March, 2017 after serving as one of MEEC's most utilized contracts. The RFP will be released in late September/early October. We hope the contract will be as flexible as the current agreement and will provide a mechanism for MEEC Members to procure the Hardware they need. The New Agreement will be structured in 5 categories: 1-Desktop, Laptop, Tablets, 2-Storage, 3-Servers and Virtualization, 4-Network and 5-Peripherals. The new Agreement will be for 9 years with 2 expansion windows after years 3 and 6. This structure is similar to the IT Professional Consulting Services Agreement.
