IT Security Products and Solutions

MEEC is actively working with PGCC on a solicitation for a new IT Security Products and Solutions Agreement. This agreement will replace the IT Security Assessment and Advisory Services Agreement and will expand its scope to include IT security software, products, and additional services and solutions. The RFP will be posted within a week. Please refer your IT security vendors to the MEEC website. The current Security Assessment and Advisory Services Agreement was extended through June 30, 2020 with the intent that new agreement will be awarded by late Spring.

Microsoft Agreement

MEEC is currently in the second year of the MEEC/ Microsoft agreement. In this agreement, licensing is based on FTE (full time equivalency) of faculty and staff. When the agreement was negotiated, Microsoft began using headcount as the method to purchase licenses. Headcount will be the means used to purchase licenses in future agreements.

Though this switch will not fully go into effect until the new Microsoft agreement is established in 2023, there are increases in the current agreement which, if applicable, will assist all in a better understanding the impact of moving from FTE to Headcount.

The current agreement expires in 2023 and though that seems a way off, for budgeting purposes and to help all better understand the effects of the change, MEEC will begin educating the MEEC community on this transition. To assist developing your strategy moving forward, webinars will be scheduled to educate members on the potential impact this move will have on your institution.

Hardware Agreement

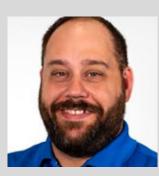
